	Representatives from EPIC came to discuss EPIC training for students:	
	EPIC has updates every year or two which translates to different versions of EPIC	
	being used at different facilities	
	 Every facility has its own unique version of EPIC 	
	 There is not a standard EPIC training for nursing students at the different facilities 	
	• 50-80% of students come in with some form of EPIC training (according to Denver	
	Health survey)	
	• Currently, the VA and HealthONE are not on EPIC in the Denver Metro area. In light	
	of this, could student training center on facility specifics? This should be a goal, but	
	we must figure out how the student gets their primary class.	
	• Could we have a test for students that measures their level? Students could then take a	
	class based upon their knowledge That's a possibility but this test must be	
	developed. Getting everyone to agree on what would be considered core knowledge is	
	a challenge.	
	• Can you offer EPIC training on more days than just Tuesdays? No—this is the only	
	time when trainers are available.	
	 At some facilities, EPIC training is provided by Clinical Scholars on first day of 	
	clinical. Could this be a possible? —Denver Health and Centura facilities require	
	their trainers to be certified to teach EPIC, requiring up to six weeks of training.

	 Regarding EPIC online modules, EPIC is very stringent in making its information available online; it would have to be password protected and closely monitored. Could the school pay for EPIC to train all of their students?—They would have to come to a hospital site where EPIC has been uploaded to the computers. Some sites have received positive feedback from in-seat students, saying they appreciated the longer training because training at other sites has been lax. This is another good reason to do longitudinal placements when possible because of the issues with EPIC training (lengthy) Could we offer training in the evening which could help with student conflicts? They will ask their trainers. Could facility have a super user that goes through EPIC training that could then train students on campus? Problem—If Super User went through the lengthy training process, they would still only be certified to teach at one facility. Future Possibilities— Competency exams Training in evenings (after 4pm) Advanced notice of classes available to schools distributed through ACE contact list Task force was developed to center on providing standardized approach with following members: Nancy Near- Perse (Porter/Littleton Adventist), Darleen Collin (ACC), Allison Moravec-Rice (CU), Joanna Hill (DSN), Greg Dehler (Regis), Dalia Ghosh (DH), Hannah Martin (Metro) 	Task Force will be contacted to begin finding short and long-term resolutions.
